Supply of Cotto d'Este porcelain stoneware tiles for walls and floors.

Product characteristics

Cotto d'Este - Blustyle coloured-body porcelain stoneware tiles, unglazed, composed of a very fine mixture of quality clay with the addition of feldspar, quartz and kaolin, manufactured by dry pressing of atomized powders and subsequently sintered by industrial firing at temperatures above 1200°C.

The complete vitrification of the tiles allows for a compact, non-absorbent, frost-proof product, resistant to bending, impacts, staining, chemical attack and thermal shock.

Safetouch: cutting-edge technology that makes ceramic surfaces smoother and more pleasant to the touch, while maintaining high standards of slip resistance, hygiene, ease of cleaning and maintenance.

Compliance with EN 14411-G / ISO 13006-G

The GEOS collection is in compliance with the regulations required for first quality products in Italy and Europe UNI EN 14411-G and internationally through ISO 13006-G.

Quality and environmental certifications

The conservation of the product characteristics is guaranteed by the Quality Management System put into practice by Cotto d'Este in its plants and certified in accordance with UNI EN ISO 9001.

The collection is manufactured in plants with UNI EN ISO 14001 certified Environmental Management Systems (internationally recognized standard) and EMAS (Regulation CE 1221/09 - eco-management and audit community system). The collection helps to meet the criteria for obtaining LEED credits. The content of "pre-consumer" recycled material is 40%, as certified by a qualified external body (LEED V4 Regulations - MR Credit).

The product contains no VOC (volatile organic compounds) and got the GREENGUARD GOLD certification.

The Environmental Product Declaration (EPD) is available, this tool communicates clearly the environmental performances of the GEOS collection based on its Life Cycle Assessment (LCA).

For all the items in the collection, the calculation of the carbon footprint (PCF) over the entire life cycle is available, expressed as CO₂ equivalent per unit of product, certified according to ISO 14067.

The collection complies with the technical specifications and contractual conditions applicable to porcelain stoneware outlined in the Ministerial Decree of 23 June 2022 "Minimum environmental criteria for the contracting of the design and execution of works for building projects".
